This refers to the Department Memorandum (DM) No. 2020-0458 dated October 12, 2020 entitled "Submission of 2020 Purchase / Consignment Orders and List of Procured / Consigned Medicines and Medical Devices and Supplies". The data to be submitted are essential for the computation of the 2021 Drug Price Reference Index (DPRI).
